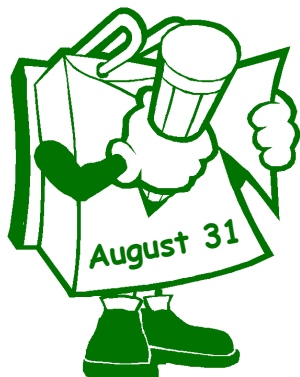

# WHAT'S NEW AT



## NEW LEGISLATION

We've heard more than enough about those rebate checks, but there are other provisions of the *Economic Stimulus Act of 2008* that have not been as well publicized. Generous expensing and bonus depreciation rules may affect your business clients when purchasing equipment—especially automobiles—in 2008. Among the provisions:

- For tax years beginning in 2008, the maximum 179 expensing limit for new equipment is \$250,000;
- For equipment placed in service in 2008, there is a bonus first-year depreciation deduction of 50% of the adjusted basis of the qualifying property;
- The luxury auto cap on first year depreciation increases by \$8,000 for vehicles that qualify;
- Bonus depreciation will be allowable for AMT as well as regular tax purposes.

The *Heroes Earnings Assistance and Relief Act of 2008* increases the failure to file penalty for late tax returns filed after 2008, as well as containing numerous tax breaks for the military. These include:

- Military taxpayers receive a stimulus rebate even though one spouse lacks a social security number;
- Existing option to include combat pay in income for EITC purposes made permanent;
- Existing provision allowing active-duty reservists to withdraw funds from a retirement plan penalty-free made permanent;
- Special home-sale exclusion rules for employees in the intelligence community made permanent;
- New survivor benefits for beneficiaries of military personnel killed in service.

Due to a clerical error, Congress had to twice override the President's veto to pass the *Food, Conservation, and Energy*

*Act of 2008*. The act contains various tax provisions related to farmers, increases corporation estimated payments for large corporations, increases and indexes the dollar thresholds for the optional method of computing self-employment tax, and includes several other tax credit changes.

## NEW IRS PUBLICATION

IRS Publication 4681 explains tax rules for “canceled debts, foreclosures, repossessions, and abandonments.” The publication covers the 2007 change exempting up to \$2 million of mortgage debt forgiven on a primary home and discusses several other exemptions for waived debts. We have added the text of the publication to the CD and online versions of *Tax Research*.

Several *TaxTools* modules deal with issues raised in Publication 4681, including: *Foreclosure and Voluntary Conveyance*; *Foreclosure - Two Loans*; *Repossession of Personal Property*; *Repossession of Real Property*; and new this year, *Cancellation of Debt Worksheet - Insolvency*.

The *Cancellation of Debt Worksheet* calculates the amount of cancellation of debt income that may be excluded from income due to insolvency. The module includes Form 982, *Reduction of Tax Attributes Due to Discharge of Indebtedness*.

- Print paychecks on preprinted checks, as pay stubs, or on blank check stock using MICR font—a \$139 value included at no charge.
- Produce payroll for an unlimited number of employers with an unlimited number of employees.
- Import QuickBooks® after-the-fact paycheck data to save data entry time.
- Track workers' compensation and create reports.

## REMINDERS...

### Shipping Policy

We have added a “no CD” option for customers who wish to save on shipping by downloading all of their CFS programs from the Internet. CFS customers can now choose from the following shipping options:

1. Receive the initial release of each program on CD and download all updates for **\$7 per order**.
2. Receive the initial release and all significant updates on CD for **\$25 per year**.
3. Download the program and all updates: **no CDs = no shipping charge**.

There are exceptions to this policy. Users of the CD versions of *Fill-N-Print Tax Forms* or *Tax Research* do not have a choice of shipping options, as they must receive several scheduled CD shipments.

Also, due to the number of updates required, users of *NY Sales Tax Preparer* **must** download all updates from the Internet, and therefore cannot choose option two.

California customers will receive an added benefit by choosing the third option. There is no sales tax on programs downloaded from the Internet!

### Don't forget to download and install your software!

Remember—if you requested the “no CD” shipping option (see *Shipping Policy*, above), you will not receive a CD, so don't forget to download and install your purchased CFS software!

Make sure we have your current e-mail address and our e-mails are not being blocked by your spam blocker, so that we can remind you about updates.

You can also stay informed of updates by periodically checking the “News & Updates” section of our web site at [www.taxtools.com](http://www.taxtools.com).

### MyCFS

A *MyCFS* account allows you to shop securely at our online store, as well as giving you secure access to your personal customer information.

You can view your order history and renewal information, update your firm name or address, look up license codes, and see if you have early renewal vouchers to apply. Your *MyCFS* account is also the key to accessing *CFS Tax Research Online*.

If you don't have a *MyCFS* account, it's easy to register. Just go to [www.taxtools.com](http://www.taxtools.com) and click on **Create Account** under the **MyCFS** menu. You will need to provide a valid e-mail address and a password.

**NOTE:** In order for us to keep track of whether or not customers have received their programs and updates, we now require you to be logged in to your *MyCFS* account to download software from our web site.

### Please Keep Us Posted!

If you have changed the name, address, or phone number of your firm, you need to let CFS know about it. Your firm information needs to be accurate and up-to-date so that you receive our mailings, so that we can notify you of program updates, and most importantly, so that your license code functions correctly to give you access to the programs you have purchased.

You can easily update your firm information online. Go to [www.taxtools.com](http://www.taxtools.com) and select **Address Change** from the **MyCFS** menu. You can also fax changes to us at 805-522-0187. Please be sure to include your customer ID number.

We prefer to have firm information changes in writing, but for simple changes such as updating or correcting a phone number or an e-mail address, or if you have any questions, please call our customer service department at 1-800-343-1157.

## CFS POLICIES AND DISCLAIMERS

### Return/Refund Policy

Software and tax supplies returns will be accepted no later than 30 days from receipt of item(s). All tax year forms/envelopes must be returned sealed and unused within 30 days of receipt, but no later than December 15th of the same tax year. All refunds will be paid less shipping charges.

Shipping damage must be reported directly to the carrier as soon as possible (no more than 10 days).

### Free Shipping

There is no shipping charge or sales tax if you download the program and all updates and do not receive a CD. However, if you later request a CD, CFS is required by law to charge sales tax on the original order.

### Update CD Service

There is a charge of \$25 if you would like the initial release and all major updates on CD. This does not apply to CD versions of Tax Research or Fill-N-Print Tax Forms, and is not available for NY Sales Tax Preparer.

### Multi-Program Network License

You can purchase network upgrades for CFS programs for an additional fee. However if you purchase several CFS programs, you might want to consider our Multi-Program Network License, which upgrades all CFS programs to the network version for an annual price of \$299.00. The Multi-Program Network License is not a stand-alone program—you must buy the single-user programs you wish to upgrade. This offer does not apply to Fill-N-Print.

### Financial Planning Tools 2008

The 2008 program will function through May 31, 2009. To use the program after that date, you must order the 2009 program. The 2008 and 2009 programs may be purchased together for a special discount price of \$550.
