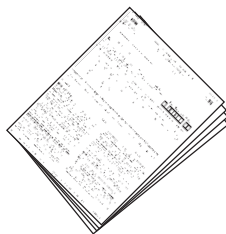

IRS REVISES FORM 1096

The IRS recently made changes to Form 1096. Two IRS offices were eliminated, necessitating changes in the mailing address section of the Form 1096 instructions. The old form has only the year **2006** in the lower right corner. The new version is marked **Rev. 7-2006**.

Unfortunately, the change was made after our forms orders had already shipped. However, replacement packs of the new forms were recently shipped, free of charge.

If you received the old forms, please discard them and use the new forms in the replacement shipment.

WHAT'S NEW AT



PDF995 ADDS PDF FILE SUPPORT TO CFS SOFTWARE

PDF995 is a printer driver created by *Software995* for exporting PDF files. When installing a CFS program or update, the user will be prompted to install the *PDF995* driver. Once the driver has been installed, the user can create a PDF file of any printout simply by selecting the *PDF995* printer driver in the printer dialog box at the beginning of a print job.

CFS programs take advantage of several powerful features of the *PDF995* driver. When selecting *PDF995* as the printer driver, an options dialog box will appear. A *Save Settings* button will save all options settings to be used for the next PDF file. Users may check options to:

- **View PDF (launch default PDF viewer)** – This option will display the PDF file in the computer's default PDF viewer, usually *Adobe Acrobat Reader* or *Adobe Acrobat*. Your computer must have a program installed to view PDF files and the PDF file extension must be associated with it.
- **Create Email to Client with PDF attachment** – This option will create an e-mail message to the current client (if the client has an e-mail address entered in the Client database) with the PDF file as an attachment. The computer must have a MAPI compliant e-mail program (i.e., *Outlook* or *Outlook Express*; not web-based e-mail such as Yahoo or AOL). The e-mail creation screen will be displayed on screen for the user to add a subject and message before sending it.
- **Add Stamp to PDF** – This option will create a diagonal gray stamp (watermark) across all pages of the PDF file. The user may specify the text of the stamp in the adjacent box.

The *PDF995* driver gives the following file output options:

- **Save to Client's folder** – The Save As dialog box will open to the current client's folder. The user may then enter the desired file name. PDF files saved in the client's folder will appear on the Client Folder pane of the main program window and may be viewed by double clicking the name of the PDF file.
- **Save to My Documents folder** – The Save As dialog box will open to the user's My Documents folder.
- **Save to Specified Directory** – The Save As dialog box will open to the drive and directory specified by the drive and directory lists shown.

The latest versions of *TaxTools*, *Small Business Tools*, *CA Sales Tax Preparer*, and *NY Sales Tax Preparer* include the *PDF995* driver. The driver will be added to *CFS Payroll System* in the near future.

FORMS 1099-INT & 1099-R DELAYED

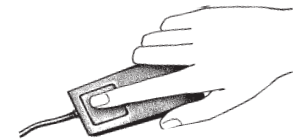
Due to an IRS delay, Forms 1099-INT and 1099-R were not available for the initial release of *CFS W2/1099 Payroll System*.

NEW SECTION 199 MODULE IN TAXTOOLS

A new module was added to *TaxTools 2006* in a recent update. The *Domestic Production Activities Deduction Worksheet* will help you calculate the new Section 199 deduction and fill out and print *Form 8903*, *Domestic Productions Activities Deduction*.

The user can select one of three methods to calculate the deduction. The resulting data will be transferred to *Form 8903*.

PENSION PROTECTION ACT OF 2006 BRINGS CHANGES

The *Pension Protection Act of 2006* signed recently by President Bush repeals the sunset provisions of EGTRRA relating to pensions and IRAs. There are also some changes to the rules for charitable contributions that your clients need to be made aware of.

Substantiation is required for all cash contributions to charity, regardless of the amount. The donor must maintain a record of the contribution by a bank record or written communication showing the name of the donee organization, date of the contribution and the amount. Even cash contributions in the church collection plate will require a written receipt. *This provision is effective for contributions made in taxable years beginning after August 17, 2006, which means 2007 for calendar year taxpayers.*

Donations of used clothing or household items must be in good condition or better. Having a receipt for seven bags of clothing will not be enough substantiation for a \$700 non-cash contribution. Your client will need detailed lists or pictures to prove that the items were in good condition. *This provision is effective for contributions made after August 17, 2006.*

Tax-free distributions from IRAs will be allowed for charitable purposes. For tax years 2006 and 2007 taxpayers who are age 70½ or older may exclude up to \$100,000 in “qualified charitable distributions” from their AGI. A qualified charitable distribution must be made directly by the IRA trustee to a charitable organization. Qualified charitable distributions are taken into account for purposes of the minimum distribution rules.

CFS TaxTools will be updated for provisions of the *Pension Protection Act of 2006*. We will also be adding letters addressing the new rules to *Tax Corresponder*, making it easy for you to notify your clients of changes that will affect their year-end tax planning.

Get Your License Code Now at MyCFS!

You can now use your *MyCFS* account to immediately look up your license code online without having to check your e-mail.

Your *MyCFS* account gives you secure access to your customer information, as well as allowing you to shop securely at our online store. You can view your order history, see if you have vouchers available, and view and fill out your renewal order form online.

Your *MyCFS* account is also the key to accessing CFS Online Research products you have purchased (*Tax Research, California Research, Audit & Collections*).

If you don't have a *MyCFS* account, it's easy to register. Just go to www.taxtools.com and click on “MyCFS” under the *Support* menu. On the *MyCFS* page, click on “Register for a MyCFS Account.” You will need to provide a valid e-mail address and a password.

Payroll System W2/1099 License Code Reminder

Remember—when you install *CFS Payroll System W2/1099*—even if you have already installed *Payroll System 941/940*—**you may need to enter a new license code.**

Your license code is printed on your receipt. You can also look it up at www.taxtools.com by clicking on **License Code Verification** under **Quick Links** or, if you have a **MyCFS** account, by selecting **License Codes** from the **MyCFS** menu.

When you install the program, make sure that you are using the latest code. (It may vary only slightly from your old license code.) **You must enter the correct code to activate the program.**

We Welcome Feedback

Most CFS programs allow users to submit suggestions or report problems from within the program.

Under the **Internet Options** menu, select **CFS Survey/Problem Report** to: submit recommendations for worksheets, forms, or enhancements; notify us of a problem you are experiencing with the program; help us evaluate the program by submitting a module usage report which tells us which modules you are using the most.

The report may be submitted to CFS immediately via Internet—either anonymously or with your customer information—or printed and faxed to us.

CFS POLICIES AND DISCLAIMERS

Return Policy

Software returns will be accepted no later than 30 days from receipt of program(s). If the order has already been shipped, a refund will be granted minus shipping.

Forms returns will be accepted no later than 30 days from receipt of order but not after 12/15/06. Forms orders placed after 12/15/06 cannot be returned.

Free Shipping

There is no shipping charge or sales tax if you download the program and all updates and do not receive a CD. However, if you later request a CD, CFS is required by law to charge sales tax on the original order.

Update CD Service

There is a charge of \$25 if you would like the initial release and all major updates on CD. This does not apply to Research programs and Fill-N-Print Tax Forms CD, and is not available for NY Sales Tax Preparer.

Multi-Program Network License

You can purchase network upgrades for CFS programs for an additional fee. However if you purchase several CFS programs, you might want to consider our Multi-Program Network License, which upgrades all CFS programs to the network version for an annual price of \$299.00. The Multi-Program Network License is not a stand-alone program—you must buy the single-user programs you wish to upgrade. This offer does not apply to AME Payroll or Fill-N-Print programs.

Financial Planning Tools 2006

The 2006 program will function through May 31, 2007. To use the program after that date, you must order the 2007 program.

Quick Reference Guide

This program is included in the Tax Research and CA Research programs but is also available as a stand-alone program for \$39.00 for first-time users and \$29.00 for renewals.
