NEW KIDDIE TAX RULES FOR 2008

New Rules...

The 2007 Small Business Act contains changes which may impact parents of college-aged children beginning in 2008. For a child subject to these rules, the child's unearned income over \$1,700 will be taxed at the parent's tax rate, which is presumably higher.

For children under age 18, nothing has changed. However, the new law expands the kiddie tax to apply to children that turn age 18 during the tax year, or turn age 19-23 if the child is a full-time student.

These older children are exempt from the new kiddie tax rules if their earned income exceeds one-half of their total support for the year.

Tax-Planning Strategies...

Here are a few tax-planning strategies to help your clients avoid or minimize the effects of the new law:

If your client has a child who is or will be age 18 to 23 and is a full-time student in 2007, consider taking any unrealized long-term capital gains in 2007.

To avoid the higher kiddie tax in the future, consider having the client move any income-generating securities into tax-free funds, growth stocks that do not generate dividends, or companies that pay qualified dividends.

Starting in 2008, consider having a self-employed client hire their child to work in their business. Remember—if the child's earned income exceeds one-half of their support, the child will not be subject to the kiddie tax.

CHANGES TO W-2

The IRS has made several changes to the 2007 Form W-2. Most importantly, the location of the employee's Social Security number was moved from box d to box a. This was done to prevent the SSN from being seen when the form is in a window envelope.

W2/1099 Payroll System has been updated for the form changes. We sell red scannable versions of the new W-2 and W-3, as well as blank, perforated stock for printing scannable black forms.

We have also redesigned our "Envelope A" to better fit the new form. However, if you have a supply of the old Envelope A's, *Payroll System* will still be able to generate W-2's to fit them.

SAFEGUARDING TAXPAYER DATA

In today's world of instant electronic data transmission, it is more difficult than ever to keep personal information from going astray. Here at CFS, we have taken steps to ensure the security of our customers' data. Have you done the same for your clients?

The IRS recently released Publication 4557, *Safeguarding Taxpayer Data - A Guide for Your Business*. The publication contains guidelines to help tax professionals and other service providers:

- Preserve the confidentiality and privacy of taxpayer data by restricting access and disclosure;
- Protect the integrity of taxpayer data by preventing improper or unauthorized modification or destruction; and
- Maintain the availability of taxpayer data by providing timely and reliable access and data recovery."

Checklists contained in Publication 4557 will soon be incorporated into *CFS Small Business Tools*. *Small Business Tools* contains over 150 modules essential to starting, running, and terminating a small business, with the same convenient interface as our other toolbox programs.

REMINDERS...

Don't forget to download and install your software!

Remember—if you requested the “no CD” shipping option (*see below*), you will not receive a CD, so don't forget to download and install your purchased CFS software!

Make sure we have your current e-mail address and our e-mails are not being blocked by your spam blocker, so that we can remind you about updates.

You can also stay informed of updates by periodically checking the “News & Updates” section of our web site at www.taxtools.com.

Shipping Policy

We have added a “no CD” option for customers who wish to save on shipping by downloading all of their CFS programs from the Internet. CFS customers can now choose from the following shipping options:

1. Receive the initial release of each program on CD and download all updates for **\$7 per order**.
2. Receive the initial release and all significant updates on CD for **\$25 per year**.
3. Download the program and all updates: **no CDs = no shipping charge**.

There are exceptions to this policy. Users of the CD versions of *Fill-N-Print Tax Forms* or *Tax Research* do not have a choice of shipping options, as they must receive several scheduled CD shipments.

Also, due to the number of updates required, users of *NY Sales Tax Preparer* **must** download all updates from the Internet, and therefore cannot choose option two.

California customers will receive an added benefit by choosing the third option. There is no sales tax on programs downloaded from the Internet!

Note: if you choose the “no CD” option, you will not receive a printed receipt. We will e-mail your receipt to you.

Payroll System W2/1099 License Code Reminder

Remember—when you install **CFS Payroll System W2/1099**—even if you have already installed **Payroll System 941/940**—you **may need to enter a new license code**.

Your license code is printed on your receipt. You can also look it up at www.taxtools.com by clicking on **License Code Verification** under **Quick Links** or, if you have a **MyCFS** account, by selecting **License Codes** from the **MyCFS** menu.

When you install the program, make sure that you are using the latest code. (It may vary only slightly from your old license code.) **You must enter the correct code to activate the program.**

MyCFS

A *MyCFS* account allows you to shop securely at our online store, as well as giving you secure access to your personal customer information.

You can view your order history and renewal information, update your firm name or address, look up license codes, and see if you have early renewal vouchers to apply. Your *MyCFS* account is also the key to accessing *CFS Tax Research Online*.

If you don't have a *MyCFS* account, it's easy to register. Just go to www.taxtools.com and click on “MyCFS” under the Support menu. On the *MyCFS* page, click on “Register for a MyCFS Account.” You will need to provide a valid e-mail address and a password.

NOTE: In order for us to keep track of whether or not customers have received their programs and updates, we now require you to be logged in to your *MyCFS* account to download software from our web site.

CFS POLICIES AND DISCLAIMERS

Return Policy

Software returns will be accepted no later than 30 days from receipt of program(s). If the order has already been shipped, a refund will be granted minus shipping.

Forms returns will be accepted no later than 30 days from receipt of order but not after 12/15/07. Forms orders placed after 12/15/07 cannot be returned.

Free Shipping

There is no shipping charge or sales tax if you download the program and all updates and do not receive a CD. However, if you later request a CD, CFS is required by law to charge sales tax on the original order.

Update CD Service

There is a charge of \$25 if you would like the initial release and all major updates on CD. This does not apply to CD versions of Tax Research or Fill-N-Print Tax Forms, and is not available for NY Sales Tax Preparer.

Multi-Program Network License

You can purchase network upgrades for CFS programs for an additional fee. However if you purchase several CFS programs, you might want to consider our Multi-Program Network License, which upgrades all CFS programs to the network version for an annual price of \$299.00. The Multi-Program Network License is not a stand-alone program—you must buy the single-user programs you wish to upgrade. This offer does not apply to AME Payroll or Fill-N-Print programs.

Financial Planning Tools 2007

The 2007 program will function through May 31, 2008. To use the program after that date, you must order the 2008 program. The 2007 and 2008 programs may be purchased together for a special discount price of \$550.
